## REPRODUCTION PRICES

### Digital copies:

Digital image of photographic print (original size up to A3): £5 per print (300dpi JPG supplied)

### Paper photocopies (only available for non-rare books and journals):

Black and white photocopy (up to A4): 35 pence

Black and white photocopy (A3): 70 pence

## SERVICE STANDARDS

1. Digital scans will be supplied as 300dpi JPGs in colour.
2. If you require higher resolution copies or copies for publication/reproduction please contact us for further information.
3. Where items are too fragile to be photocopied, a digital photo is the only alternative.
4. If the item is too fragile to be photographed, copying may be refused altogether.

## POSTAGE/DELIVERY

- Digital photos will be sent via email or via a digital file transfer service.
- Orders will only be processed on receipt of a signed copyright declaration.
- Orders will not be dispatched until payment has been received.
- We aim to delivery digital files within 14 days of payment, but at peak times delivery may take **up to 30 days**.
- Administration & Postage charge to UK addresses is £2.50 per 40 printed pages.
- Administration & Postage charge to OVERSEAS addresses is £5 per 40 printed pages.
